**Section 2: HAZARDS IDENTIFICATION**

**Classification:** This substance does not need to be classified according to regulation (EC) No. 1272/2008.  
**Label:** This product does not need to be labeled in accordance with EC directives or respective national laws.  
**Other hazards:** May cause an allergic reaction upon exposure, inhalation, skin contact and swallowing.

**Section 3: COMPOSITION/INFORMATION ON INGREDIENTS**

**General information:** Aqueous solution of recombinant *Arachis hypogaea* Ara h 8.0101, a minor food allergen.

**Ingredients:** According to regulation (EC) No. 1272/2008, hazardous and carcinogenic ingredients with a concentration of less than 1% and 0.1%, respectively, are not considered "relevant ingredients". Hazardous and carcinogenic ingredients that exceed these criteria are listed below.
