**Section 2: HAZARDS IDENTIFICATION**

**Classification:** This substance does not need to be classified according to regulation (EC) No. 1272/2008.

**Label:** This product does not need to be labeled in accordance with EC directives or respective national laws.

**Other hazards:** This product contains protein of human origin. Each donor has been tested and found to be non-reactive to HBs antigen and HIV-p24 antigen as well as negative for anti-HBc, anti-HIV1/2 and, anti-HCV and anti-*Treponema pallidum*. Additionally, samples were tested negative for HIV-1-RNA, HCV-RNA, HBV-DNA, HAV-RNA, Parvovirus-B19-DNA. However, no known test can offer complete assurance that the viruses/infectious agents that cause a disease are not present. Proper precautions and biological containment should be taken when handling materials of human origin, due to their potential biohazardous nature.

**General information:** Aqueous solution of non recombinant human Thyroglobulin (TG).
